Starting from 2017 until now, I'm also responsible for the Legal Dept. of the FCA Services Companies and its affiliates - in Poland, France, UK, Germany, Belgium, Spain, Serbia, Malesia, US and Brasil.

I have consolidated my professional experience in an international context - as legal counsel and as auditor /compliance officer (performing activities also outside Italy - in US, Brasil, France, Spain, Switzerland,...).

The daily activities is executed working with cross-functional and worldwide teams to achieve business objectives: Human Resources - on employees initiatives - Legal, Cyber Security/Information Technologies Dept., Marketing, Product Development and Purchasing Dept. for the agreements negotiation with services providers or with external partners to develop data initiatives (e.g. data monetization, big data lake, connectivity projects, targeting/profiling and customer loyalty, retention data, artificial intelligence,...).

With the Internal Audit the cooperation is close and fruitful. In particular, they receive my support drafting the annual audit plan on privacy topic and in the training initiatives that I usually project and customize for them.

Below the main activities and responsibilities:

- Identify and evaluate the company's data processing activities supporting the census activities on the data processing and maintain records of processing operations;
- Support the internal department drafting, negotiating and finalizing the privacy documents for the business activities;
- Provide advice and instructions on how to conduct Data Protection Impact Assessments (DPIAs);
- Monitor data management procedures and compliance within the companies also coordinating the internal audit activities;
- Participate in meetings with managers to ensure privacy by design at all levels;
- Keep regularly meetings and relationship with the Data Protection Authorities and support the Group Companies during the privacy inspections;
